Inspection Summary

A statement of Deficiency (SOD) and a Plan of Correction (POC) was issued to the Facility at the completion of the inspection. The SOD documented identified deficiencies in the following regulation categories:

- Administrative records
- Recordkeeping for children
- Recordkeeping for staff
- Suitability for employment (criminal background checks)
- Environmental (Indoor)
- Health and safety

There were deficiencies cited during this inspection that presented imminent danger to the health, safety and welfare of children.

121.3 - Failure to maintain child: adult ratio at all times

Facility corrected eminent danger during this inspection on 7/3/18.

Consistent with the plan of correction, the facility corrected all areas of non-compliance by 4/18/19.
