Finding Associated with Complaint

591-1-1-.32(7) requires that children be supervised at all times and that the persons supervising in the child care area be alert, able to respond promptly to the needs and actions of the children being supervised, as well as the actions of the chaperones and Students-in-Training, and provide timely attention to the children's actions and needs. It was determined by consultant review of video footage that there was a lack of supervision while teachers were observed to be sitting on the playground on January 6, 2020 at 3:00 p.m., while a two-year-old child was grabbed by the face by another two-year-old child while on the playground.

POI (Plan of Improvement)

The Center will train Staff and monitor to ensure they are providing supervision and watchful oversight to the children at all times.
