Finding Associated with Complaint

591-1-1-.03(8) requires a center to provide individual attention to each child by responding promptly to the child's distress signals and need for comfort. It was determined based on an investigation that a crying child was sent to the restroom to wash their face and stop crying. While the child was in the restroom, staff closed the door and turned off the light.

POI (Plan of Improvement)

The Center will provide staff training in when and how to respond appropriately to children's distress signals and need for comfort.

Finding Associated with Complaint

591-1-1-.37(e) requires the Center shall not make or condone any Staff to make a false or misleading statement to the Department in connection with any authorized investigation or inspection being conducted by the Department. It was determined based on an investigation that the director stated a false name for a staff member that had worked on the premises with an unsatisfactory criminal records check determination along with providing false statements that the staff member was no longer present at the facility. The unsatisfactory Comprehensive Records Check Determination was received by the center on January 14, 2019, and the staff member was present and caring for children after that date. Video footage revealed that the staff member with the Unsatisfactory determination was present on January 23, January 24, January 25, January 28, and January 30, 2019.

POI (Plan of Improvement)

The Center will not make, or condone Staff to make false or misleading statements to the Department.

Finding Associated with Complaint

591-1-1-.11(2) requires that Personnel not: physically or sexually abuse a child or engage or permit others to engage in sexually overt conduct in the presence of any child enrolled in the Center; inflict corporal/physical punishment upon a child; shake, jerk, pinch or handle a child roughly; verbally abuse or humiliate a child which includes, but is not limited to, the use of threats, profanity or belittling remarks about a child or his family; isolate a child in a dark room, closet or unsupervised area; use mechanical or physical restraints or devices to discipline children; use medication to discipline or control children's behavior without written medical authorization issued by a licensed professional and given with the parent's written consent; restrict unreasonably a child from going to the bathroom; punish toileting accidents; force-feed a child or withhold feeding a child regularly scheduled meals and/or snacks; force or withhold naps; allow children to discipline or humiliate other children; or confine a child for disciplinary purposes to a swing, highchair, infant carrier, walker or jump seat. It was determined based on an investigation that one staff member would send children to an unsupervised area, such as the bathroom, and tell the children to turn off the lights and close the door as a form of discipline.

POI (Plan of Improvement)

The Center will take immediate action to ensure the action/conduct has ceased; train/review appropriate child guidance techniques with center staff; and have a system in place to monitor and identify inappropriate actions.

Finding Associated with Complaint

591-1-1-.09(1)(e) requires that no actual or potential Director, Employee or Provisional Employee of a Child Care Learning Center with an unsatisfactory Fingerprint Records Check Determination or an unsatisfactory Comprehensive Records Check Determination may be present at a Center when any child is present for care or reside at a Center. It was determined based on an investigation that one staff member was observed to be present and working with children with an unsatisfactory Comprehensive Records Check Determination. The unsatisfactory Comprehensive Records Check Determination was received by the center on January 14, 2019, and the staff member was present and caring for children after that date. Video footage revealed that the staff member with the Unsatisfactory determination was present on January 23, January 24, January 25, January 28, and January 30, 2019.

POI (Plan of Improvement)

The Center will ensure that no actual or potential Director, Employee or Provisional Employee of a Child Care Learning Center with an unsatisfactory Fingerprint Records Check Determination or an unsatisfactory Comprehensive Records Check Determination is present at the Center when any child is present for care or reside at a Center.

Staffing and Supervision

Not Met

Finding Associated with Complaint

591-1-1-.32(7) requires that children be supervised at all times and that the persons supervising in the child care area be alert, able to respond promptly to the needs and actions of the children being supervised, as well as the actions of the chaperones and Students-in-Training, and provide timely attention to the children's actions and needs. It was determined based on an investigation that on January 17, 2019 children were sent to the restroom inside of the classroom to "cool down." The children were left in the restroom for up to fifteen minutes unsupervised.

POI (Plan of Improvement)

The Center will train Staff and monitor to ensure they are providing supervision and watchful oversight to the children at all times.
