If you do not have this liability insurance, you are required to post a notice with ½ inch letters in a conspicuous location in the program, notify the parent or guardian of each child in care in writing, obtain their signature to acknowledge receipt and maintain this written acknowledgment on file at the program at all times while the child attends the program and for 12 months after the child's last date of attendance. (O.C.G.A. Section 20-1A-4)

591-1-1-.30(2)(b) requires that Center Staff shall not place objects or allow objects to be placed in or on the crib with an infant such as but not limited to toys, pillows, quilts, comforters, bumper pads, sheepskins, stuffed toys, or other soft items. It was determined by consultant's observation that two cribs containing two alert children were observed to have the following items in them: two dolls, one stuffed animal and three bibs. Consultant discussed safety rules with the director. The director advised that the children need something to do while awake in the crib. Consultant advised that when children are awake it is expected that staff interact with the children.
