Comments

This Licensing Study is the second regulatory visit for Mother Goose Nursery School this 2017 - 2018 fiscal year.

The consultant reviewed all staff files and finds that one staff member hired November 6, 2017 does not have a local or satisfactory fingerprint criminal records clearance determination letter on file. Additionally, a second employee hired May 1, 2018 has a satisfactory comprehensive fingerprint criminal records clearance determination with BFTS however portability expired March 21, 2015. A one-day-letter was left with the center director.

The center director stated no field trips or routine transportation is provided. Medication is administered.

The center currently has a one-star Quality Rating.

Finding

591-1-Ī-.30(4). requires that if cots and mats are stored in the children's activity room or area, they shall be stored to prevent children's access to them and to allow maximum use of play space. When storage is available and used for the storage of cots and mats that allows the cots, mats and any bedding to be stored without touching any other cots, mats or bedding, the bedding may be left on the cot or mat. When such storage is not available for the cots and mats, each child's bedding shall be kept separate from other children's bedding and stored in containers marked for individual use, such as, but not limited to, bins, cubbies, or bags. It was determined based on the consultant's observation that four mats are being stored inside of the infant and one-year-old classroom and are not covered. Additionally, five cots are being stored inside of the two-year-old classroom and are not covered. Additionally, twelve cots are being stored inside of the three and four-year-old classroom and are not covered.

POI (Plan of Improvement)

The Center will store cots and mats so children do not have access to them and they don't take up play space and will store them so each child's bedding is separate from the others.

Finding

591-1-1-.09(1)(a) requires the Center to ensure that every Director, Employee and Provisional Employee of the Child Care Learning Center has a satisfactory records check determination before the individual is present at the Center or before the individual resides in a Center. It was determined based on the consultant's review of all staff files, a staff member's statement and the director's statement that a staff member was hired November 6, 2017 and has no local or satisfactory fingerprint criminal records clearance determination on file. A one-day-letter was left with the center director.

POI (Plan of Improvement)

The Center will obtain the Required Satisfactory Records Check Determination before an individual is present at the Center while any child is present for care or before residing in a Center.

Finding

591-1-1-.09(1)(i) requires that if the Center accept a satisfactory determination letter issued by the Department for a potential Director or Employee as evidence of that individual's Satisfactory Records Check Determination, the Records Check Clearance Date must be within the preceding 12 months from the hire date, and the Center does not know or reasonably should not know that the individual's satisfactory status has not changed. It was determined based on the consultant's review of all staff files and the director's statement that one employee was hired May 1, 2018, has a comprehensive satisfactory criminal records clearance determination on file however the portability date expired March 21, 2015. A one-day-letter was left with the center director.

POI (Plan of Improvement)

The Center will ensure that each potential Employee bringing a satisfactory determination letter issued by the Department has a Satisfactory Records Check Determination that is dated within the preceding 12 months from the hire date. The Center will not employ individual's whose satisfactory status has changed.

It was determined based on the consultant's review of all staff files, training documents and the director's statement that one staff member completed six calendar hours of annual training where ten hours are required.

The Center will plan and schedule the required 10 hours of annual training each year and follow up to ensure the training is completed.
