The provider stated she does not provide liability insurance. The consultant observed a posted notice and signed parental acknowledgements.

The consultant reviewed all staff / household member files and finds a satisfactory fingerprint criminal records clearance determination letter on file. Two staff / household member have a comprehensive satisfactory letter on file and three do not. The consultant discussed that all staff / household members are required to have comprehensive criminal records checks by October 1, 2017.

The provider does not administer medication, provide field trips or transportation.

Plan of Improvement: No Plan Developed

If you do not have this liability insurance, you are required to post a notice with ½ inch letters in a conspicuous location in the program, notify the parent or guardian of each child in care in writing, obtain their signature to acknowledge receipt and maintain this written acknowledgment on file at the program at all times while the child attends the program and for 12 months after the child's last date of attendance. (O.C.G.A. Section 20-1A-4)
