- New records checks will be required to be completed if a staff member experiences a six month break in service from the child care industry
- New clearance is required at least once every five years
- Any staff member solely responsible for supervising children will be required to have completed a comprehensive background clearance
- · All staff members are required to have completed at least a national fingerprint based clearance check
- Any staff member with only the national fingerprint based clearance, must be under constant and direct supervision of a staff member with a satisfactory comprehensive records check clearance
- Facilities are required to use DECAL KOALA for Criminal Records Checks, including to verify portability of an employee

O.C.G.A. Section 42.1.12(i)(2) requires Bright from the Start: Georgia Department of Early Care and Learning to notify licensed child care programs on accessing and retrieving from the Georgia Bureau of Investigation's (GBI) website a list of the names and addresses of all registered sexual offenders. If you do not have this liability insurance, you are required to post a notice with ½ inch letters in a conspicuous location in the program, notify the parent or guardian of each child in care in writing, obtain their signature to acknowledge receipt and maintain this written acknowledgment on file at the program at all times while the child attends the program and for 12 months after the child's last date of attendance. (O.C.G.A. Section 20-1A-4)

Finding

591-1-1-.26(8) requires climbing and swinging equipment to have a resilient surface beneath the equipment and the fall zone from such equipment must be adequately maintained by the Center to assure continuing resiliency. It was determined based on observation that there was an inadequate amount of material maintained beneath the swing set, in that the ground and rubber mat material located underneath the swings was exposed where the children dug down in the ground with their feet.

POI (Plan of Improvement)

The Center will add additional resilient surfacing to the fall zones where needed and check daily, adding resilient surfacing as needed to maintain adequate resiliency.

Finding

591-1-1-.26(9) requires the playground to be kept clean, free from litter and free of hazards, such as but not limited to rocks, exposed tree roots and exposed sharp edges of concrete. It was determined based on observation that medal piece of anchoring equipment was accessible to the children beneath the swing set. Additionally, the edges of rubber mats stored beneath the swing set were observed to be accessible posing a possible tripping hazard.

POI (Plan of Improvement)

The Center will remove any litter and fix or remove hazards from the playground and will routinely monitor the playground and remove litter and hazards. The center will maintain adequate resilient surface material to cover the anchoring equipment.

Staff observed to be compliant with applicable laws and regulations.

Finding

591-1-1-.31(11) requires the Center to have qualified and sufficient direct-care, clerical, housekeeping, maintenance and other employees to ensure full compliance with these rules without neglecting the supervision of children. It was determined based on observation that there was an inadequate amount of staff present this date, in that children had to be moved from their regular classrooms to attempt to accommodate ratio requirements. It was observed that there was not enough staff to cover teacher breaks, leaving the toddler classroom out of ratio during that time period.

POI (Plan of Improvement)

The Center will ensure that an adequate number of qualified employees is available to ensure full compliance with these rules without neglecting the supervision of the children. It was discussed that the center may want to look at substitute staff to cover breaks and unexpected absences or hire additional staff.

Staffing and Supervision

591-1-1-.32 Staff: Child Ratios and Group Size(CR)

Finding

591-1-1-.32(2) requires the Center maintain Staff:child ratios in mixed-age groups based on the age of the youngest group of children that includes more than twenty percent of the total number of children in the mixed-age group. It was determined based on observation that a ratio of 1:9 was maintained in the toddler classroom (1R classroom) while a staff person was on break. A ratio of 2:9 was required, as there were three 1 year old children present and five 2 year old children present in the mixed grouping.

POI (Plan of Improvement)

The Center will provide adequate staff when there is a mixed-age group.

591-1-1-.32 Supervision(CR)

Comment

Adequate supervision observed on this date. Please ensure children are not sent inside to the restroom while outside (even with staff present inside). It was discussed that if there was only one staff person present with the children that the whole class should be escorted inside.

Finding

591-1-1-.32(7) requires that children be supervised at all times and that the persons supervising in the child care area be alert, able to respond promptly to the needs and actions of the children being supervised, as well as the actions of the chaperones and Students-in-Training, and provide timely attention to the children's actions and needs. It was determined based on observation that a child was sent inside from the outdoor play area to use to the restroom. The child ran through the Pre-K classroom both times, once when entering the building and another time while exiting the building. A staff person was observed in the three year-old classroom and the teacher responsible for the children was standing at the entry door to the building.

POI (Plan of Improvement)

The Center will train Staff and monitor to ensure they are providing supervision and watchful oversight to the children at all times. Center staff will escort the children inside when only one staff person is on the playground or call for another staff person to retrieve the child and escort them in the building to the restroom.
