The center director stated they have a total of 45 staff with 6 being new hires since the consultant's last visit. The center director stated no medication has been administered, no field trips or routine transportation provided.

 Any staff member with only the national fingerprint based clearance, must be under constant and direct supervision of a staff member with a satisfactory comprehensive records check clearance
 Facilities are required to use DECAL KOALA for Criminal Records Checks, including to verify portability of an employee

(O.C.G.A. Section 20-1A-4)
