A variety of equipment and toys were observed throughout the center.

## Finding

591-1-1-.12(2) requires that all equipment and furniture be free from hazardous conditions such as, but not limited to, sharp rough edges or toxic paint; and be kept clean. It was determined, based on observation, that vinyl furniture was observed to have tears with foam exposed throughout the center, which prevented the furniture from being cleaned and sanitized as required.

The Center will ensure that equipment and furniture are used by the age-appropriate group of children.

It was determined, based on observation, that the exhaust fan in the bathroom located in the Fourth Right Classroom was observed to not be operational on this date.

#### POI (Plan of Improvement)

The Center will fully enclose and ventilate bathroom areas, as required, and will provide adequate ventilation and sanitation in bathrooms that are not fully enclosed.

The consultant discussed the medication guidelines and that every date within the authorized date range must be documented, with comments added if the child was absent or medication was not provided.

The Center will train Staff to obtain and review parental authorizations to ensure the authorization contains complete information. The designated person(s) will monitor daily.
