#### **Finding**

591-1-1-25(3) requires the Center and surrounding premises to be kept clean, free of debris and in good repair. Hygienic measures such as, but not limited to, screened windows and proper waste disposal procedures shall be utilized to minimize the presence of rodents, flies, roaches and other vermin at the Center. It was determined based on consultant's observation of the center the fire extinguisher located at the front right entrance of the center's kitchen was labeled "Recharge."

## POI (Plan of Improvement)

The Center will ensure that the surrounding areas throughout the center is cleaned and make repairs where needed.

## **Technical Assistance**

Trees located on the site or that encroach onto the site from adjacent properties may have structural issues that present an elevated level of risk. Consider having these trees inspected by a certified arborist to determine their structural integrity and associated levels of risk. Consultant also discussed monitoring the bushes located on the opposite side of the back right playground fence to ensure the bushes do not become accessible to the children receiving care.

## **Finding**

591-1-1-.26(4) requires that playgrounds be protected from traffic or other hazards by a (4) four foot high fence or other barrier approved by this Department. Fencing material shall not present a hazard to children and shall be maintained so as to prevent children from leaving the playground area by any means other than through an approved access route. Fence gates shall be kept closed except when persons are entering or exiting the area. It was determined based on consultant's observation a gap was observed on the bottom of the front right fence measuring approximately 5 inches creating a potential entrapment hazard on this date.

## POI (Plan of Improvement)

The Center will routinely check the fence to determine if it is in good repair and remains at least 4 feet high, and will repair any hazards. The Center will train Staff to identify and report any fence hazards and to keep the fence gates closed when not in use.

#### **Finding**

591-1-1-.26(8) requires climbing and swinging equipment to have a resilient surface beneath the equipment and the fall zone from such equipment must be adequately maintained by the Center to assure continuing resiliency. It was determined based on consultant's observation of the center's playground less than three inches of resilient surface was observed around the fall zones of the blue swings located on the front right side of the playground. It was further determined based on consultant's observation less than three inches of resilient surface was observed around the fall zones of the red, green, yellow, and black sliding structure located on the back left side of the playground.

## POI (Plan of Improvement)

The Center will add additional resilient surfacing to the fall zones where needed and check daily, adding resilient surfacing as needed to maintain adequate resiliency.

## **Finding**

591-1-1-.26(9) requires the playground to be kept clean, free from litter and free of hazards, such as but not limited to rocks, exposed tree roots and exposed sharp edges of concrete. It was determined based on consultant's observation of the center's playground area rotting wood was observed on the lower right side of the shed located on the back left side of the playground.

## **POI** (Plan of Improvement)

The Center will remove any litter and fix or remove hazards from the playground and will routinely monitor the playground and remove litter and hazards.

It was further determined based on consultant's review of staff files one of three lead teachers did not meet the minimum academic requirements required for a lead teacher. Per director, the center is currently in the process of enrolling all staff members in a Child Development Associate class.
