591-1-1-.06(4) requires a Center first licensed after March 1, 1991, and Centers that remodel or add to existing plumbing facilities, to have the bathroom area fully enclosed and ventilated to the outside of the building with either an open screened window or functioning exhaust fan and duct system and requires Centers without fully enclosed bathrooms to ensure there is adequate ventilation to control odors and adequate sanitation measures to prevent the spread of contagious diseases. It was determined based on observation the ventilation fans are not operating properly throughout the building in each classroom on this date, and class 1L has a build-up of dust.

Finding 591-1-125(3) requires the Center and surrounding premises to be kept clean, free of debris and in good repair. Hygienic measures such as, but not limited to, screened windows and proper waste disposal procedures shall be utilized to minimize the presence of rodents, flies, roaches and other vermin at the Center. It was determined based on observation class G-1st left had baseboards missing and peeling green paint and class E back left boys restroom is missing the shield on the light fixture.

Finding 591-1-126(4) requires that playgrounds be protected from traffic or other hazards by a (4) four foot high fence or other barrier approved by this Department. Fencing material shall not present a hazard to children and shall be maintained so as to prevent children from leaving the playground area by any means other than through an approved access route. Fence gates shall be kept closed except when persons are entering or exiting the area. It was determined based on observation the following: Playground A - The fence is budging in the middle Playground C - The back fence is detached at the bottom posing a hazard, and the gate door leading from playground B to C has a 13" inch gap that could cause an entrapment. Playground D - The wood fence has peeling paint and the prongs at the bottom of the gate are detached.

For example, toddlers shall not be permitted to swing in swings designed for School-age Children. The outdoor equipment shall be free of lead-based paint, sharp corners and shall be regularly maintained in such a way as to be free of rust and splinters that could pose significant safety hazard to the children. All equipment shall be arranged so as not to obstruct supervision of children. It was determined based on observation the following:  Playground C black rubber tiles are loose posing an tripping hazard and three swings have chains that are rusting

observation the following hazards: Playground A - The sidewalk outside class 2nd Right has a 10 inch drop-off and exposure under the cement platform detaching from the surface and the part of the metal sewer top was exposed posing a hazard. Playground B - The basketball cement platform has a twelve (12) inch drop-off along the back side of the court posing a tripping hazard.
Playground C - There is exposed cement along the side posing an hazard, and a seven (7) inch drop-off from the cement sidewalk posing a hazard.
