591-1-1-.03(2) requires the Center to keep current lesson plans on site that reflect appropriate instruction practices and activities to support children's development The Center shall have sufficient and varied play and learning equipment and materials to support the above program of activities in all developmental areas. It was determined based on observation that four of four classrooms observed failed to keep current lesson plans on site as required.

POI (Plan of Improvement)

The Center will keep current lesson plans on site that include appropriate instruction practices and activities and will have sufficient and varied play and learning equipment and materials to support the activities.

591-1-1-.12 Equipment & Toys(CR)

Finding

591-1-1-.12(2) requires that all equipment and furniture be free from hazardous conditions such as, but not limited to, sharp rough edges or toxic paint; and be kept clean. It was determined based on observation that the cots used by children in the center were not in good repair evidenced by rips and tears on the edges. Based on observation, it was determined that four out of four cots in the classroom had obvious severe wear and tear creating possible hazard during use by children in the center.

POI (Plan of Improvement)

The Center will ensure that equipment and furniture are used by the age-appropriate group of children.

It was determined based on observation that two out of five cots in Room B (Left side) two year old classroom, failed to have tight-fitting sheets as required. It was further observed that the center failed to provide sheets in good repair evidenced by a rip/tear in the fitted sheet located in the infant/toddler room.

POI (Plan of Improvement)

The center will ensure that each crib has an individual, tight-fitting sheet which is changed daily or more often as needed and prior to a change of occupant.

The first aid kit, together with a first aid instruction manual which must be kept with the kit at all times, shall be stored so that it is not accessible to children but is easily accessible to Staff. It was determined based on observation that the center failed to maintain and have a first aid kit in each building and in any vehicle that contains scissors, tweezers, gauze pads, adhesive tape, thermometer, band-aids, assorted sizes, antibacterial ointment, insect-sting preparation, an antiseptic cleansing solution, triangular bandages, rubber gloves, protective eye wear, a protective face mask, and a cold pack. The following requirements for the first aid kit were not met as required -Insect Sting Preparations expired

Antibacterial Ointment expired

Antiseptic cleaning solution expired

Center Staff will provide any missing first aid kits, add any missing items to each first aid kit and will develop and use a plan for checking the kits and replacing missing items in each kit in the future. First aid kits and instruction manuals will be stored so that they kits are not accessible to children but are easily accessible to Center Staff.
