If you do not have this liability insurance, you are required to post a notice with ½ inch letters in a conspicuous location in the program, notify the parent or guardian of each child in care in writing, obtain their signature to acknowledge receipt and maintain this written acknowledgment on file at the program at all times while the child attends the program and for 12 months after the child's last date of attendance. (O.C.G.A. Section 20-1A-4)

591-1-1-.25(13) requires that potentially hazardous equipment, materials and supplies be stored in a locked area inaccessible to children. It was determined based on the consultant's observation that the following hazards were observed:

- * A black television cable was observed to be on the side of the television stand accessible to the children.
- *The silver metal kick plate on the bottom on the door exiting to the playground was observed to be broken in half posing a hazard to the children.
- *The green rug under the black chalk table had one end that was fraying and had strings exposed posing a choking hazard.
- *A one-inch hole was observed in the the wall next to the back door leaving sheet rock exposed.

POI (Plan of Improvement)

The Center will identify all hazardous items and keep them in a locked area inaccessible to children. The Center will inform all Staff about hazardous items and the safe storage of those items.
