This Monitoring Visit is the first regulatory visit for Janie Little Gems Daycare this 2018 - 2019 fiscal year.

The center currently has a two-star Quality Rating.

The center director stated no medication is administered, no field trips or transportation is provided.

The consultant reviewed all staff files and finds that each staff member has a satisfactory fingerprint criminal records clearance determination letter on file. The consultant discussed that effective October 1, 2018 all staff are required to have a comprehensive fingerprint criminal records clearance determination letter on file.

Four of the previous child records cited are no longer enrolled. The consultant reviewed a total of four child files on this visit.

Plan of Improvement: No Plan Developed
