Refutations must be submitted to Child Care Services (CCS) within 10 business days of the completion date.

If you do not have this liability insurance, you are required to post a notice with ½ inch letters in a conspicuous location in the program, notify the parent or guardian of each child in care in writing, obtain their signature to acknowledge receipt and maintain this written acknowledgment on file at the program at all times while the child attends the program and for 12 months after the child's last date of attendance. (O.C.G.A. Section 20-1A-4)

Staffing and Supervision

591-1-1-.32 Staff:Child Ratios and Group Size(CR)

Not Met

Finding Associated with Complaint

591-1-1-.32(3) requires a Center with a licensed capacity of 18 or fewer children to maintain Staff-child ratios in mixed-age groups of children under three years old based on the age of the youngest child under three years of age. Where all of the children in any one group are three years of age or older, the age of the majority of the children in the group shall determine the Staff: child ratios . It was determined based on consultant observation that the center was out of ratio on this date. The center had seven children ranging in ages of infants to three-year-old present, and the ratio needed to be maintained at one staff member to six children.

POI (Plan of Improvement)

The Center will determine and maintain Staff: child ratios as required. The provider will hire another staff, have staff come in earlier and talk with parents about the children that are not present all the time to ensure that ratios are maintained.

Correction Deadline: 5/1/2018
