591-1-1-.26(4) requires that playgrounds be protected from traffic or other hazards by a (4) four foot high fence or other barrier approved by this Department. Fencing material shall not present a hazard to children and shall be maintained so as to prevent children from leaving the playground area by any means other than through an approved access route. Fence gates shall be kept closed except when persons are entering or exiting the area. It was determined based on observation that a four inch gap was present on the right side toddler playground fence facing the parking lot causing a potential entrapment hazard. It was further determined that a four inch gap was present on the rear playground fence near water fountain on left side of preschool playground causing a potential entrapment hazard.

POI (Plan of Improvement)

The Center will routinely check the fence to determine if it is in good repair and remains at least 4 feet high, and will repair any hazards. The Center will train Staff to identify and report any fence hazards and to keep the fence gates closed when not in use.

It was determined based on review of records that seven of thirty staff members did not complete the Health and Safety Training within the first 90 days of employment.
