- All staff members are required to have completed at least a national fingerprint based clearance check
- Any staff member with only the national fingerprint based clearance, must be under constant and direct supervision of a staff member with a satisfactory comprehensive records check clearance
- Facilities are required to use DECAL KOALA for Criminal Records Checks, including to verify portability of an employee

Finding

591-1-1-.26(4) requires that playgrounds be protected from traffic or other hazards by a (4) four foot high fence or other barrier approved by this Department. Fencing material shall not present a hazard to children and shall be maintained so as to prevent children from leaving the playground area by any means other than through an approved access route. Fence gates shall be kept closed except when persons are entering or exiting the area. It was determined based on observation that there were three (3) screws on each fence corner that were protruding more than two (2) threads.

POI (Plan of Improvement)

The Center spoke with the maintenance personnel to add a nut to ensure that the screws are not protruding more than two (2) threads.

Correction Deadline: 8/30/2019

Finding

591-1-1-.26(8) requires climbing and swinging equipment to have a resilient surface beneath the equipment and the fall zone from such equipment must be adequately maintained by the Center to assure continuing resiliency. It was determined based on observation that the resilient surface underneath the tire swing measured one (1) inch when six (6) inches is required.

POI (Plan of Improvement)

The Center will contact the school's maintenance to add the mulch underneath the tire swing and check it regularly to ensure it maintains six (6) inches.

Correction Deadline: 8/30/2019

Finding

591-1-1-.26(9) requires the playground to be kept clean, free from litter and free of hazards, such as but not limited to rocks, exposed tree roots and exposed sharp edges of concrete. It was determined based on observation that there was vegetation growing through the fence all around the playground.

POI (Plan of Improvement)

The Center spoke with the Director of the School's After-School Director and communicated with the maintenance personnel and explained that the vegetation needs to be trimmed so that it is not growing through the fence. The Center will develop a plan to check the playground area daily and inform the personnel for corrections.
