- New records checks will be required to be completed if a staff member experiences a six month break in service from the child care industry

- Any staff member solely responsible for supervising children will be required to have completed a comprehensive background clearance
- All staff members are required to have completed at least a national fingerprint based clearance check
- Any staff member with only the national fingerprint based clearance, must be under constant and direct supervision of a staff member with a satisfactory comprehensive records check clearance
- Facilities are required to use DECAL KOALA for Criminal Records Checks, including to verify portability of an employee

You have received permission to operate and the form received with this report is intended to serve as a temporary license which is <u>valid for thirty(30) days</u>. #### **Finding**

591-1-1-.25(13) requires that potentially hazardous equipment, materials and supplies be stored in a locked area inaccessible to children. It was determined based on consultant's observation, the following hazardous items were found to be accessible to children:

#### Room A:

- A bottle of hand sanitizer located on the counter
- Febreeze room spray located on the counter
- OFF bug spray located on the counter
- A clear bottle labeled "bleach water" located on the counter

#### Room B:

- Teacher purse located on open shelving in the bathroom
- Teacher scissors in a cup located on the counter
- A clear bottle labeled "bleach water" located on the counter
- Broom and dust pan beside the classroom door

#### Room C:

- A clear bottle labeled "bleach water" located on open shelving
- Teacher purse located on open shelving

#### Room G:

- Teacher purse located on open shelving in the bathroom

#### POI (Plan of Improvement)

The Center will ensure that hazardous items including cleaning solutions, cleaning supplies, and teacher purses are stored in a locked cabinet or closet where they are inaccessible to children.

#### 591-1-1-.26 Playgrounds(CR)

#### Finding

591-1-1-.26(4) requires that playgrounds be protected from traffic or other hazards by a (4) four foot high fence or other barrier approved by this Department. Fencing material shall not present a hazard to children and shall be maintained so as to prevent children from leaving the playground area by any means other than through an approved access route. Fence gates shall be kept closed except when persons are entering or exiting the area. It was determined based on consultant's observation that the front left fence gate on Playground A contained a gap that was four and a half inches in width when the requirement is less than three and a half inches. Additionally, the consultant observed the back left fence gate on Playground A to contain a four inch gap when the requirement is less than three and a half inches. Further, the consultant observed sharp metal fence wires at the base of the front right fence gate on Playground A.

#### POI (Plan of Improvement)

The Center will lessen the gaps on the fence gates so that there is no more than a three and a half inch gap. Additionally, the center will remove the sharp metal from the base of the fence gate on Playground A.
