- New records checks will be required to be completed if a staff member experiences a six month break in service from the child care industry
- New clearance is required at least once every five years
- Any staff member solely responsible for supervising children will be required to have completed a comprehensive background clearance
- · All staff members are required to have completed at least a national fingerprint based clearance check
- Any staff member with only the national fingerprint based clearance, must be under constant and direct supervision of a staff member with a satisfactory comprehensive records check clearance
- Facilities are required to use DECAL KOALA for Criminal Records Checks, including to verify portability of an employee

You have received permission to operate and the form received with this report is intended to serve as a temporary license which is <u>valid for thirty(30) days</u>. #### **Finding**

591-1-1-.26(4) requires that playgrounds be protected from traffic or other hazards by a (4) four foot high fence or other barrier approved by this Department. Fencing material shall not present a hazard to children and shall be maintained so as to prevent children from leaving the playground area by any means other than through an approved access route. Fence gates shall be kept closed except when persons are entering or exiting the area. It was determined based on observation that there were bolts protruding from the gates between all playgrounds.

## POI (Plan of Improvement)

Bolts that are protruding from the fence gates towards playgrounds will be cut to no more than 2 threads beyond the nut. Even if the bolts have a cover, they can still not protrude towards the playgrounds and will need to be cut down and sanded. The Center will routinely check the fence to determine if it is in good repair and remains at least 4 feet high, and will repair any hazards.

Correction Deadline: 4/2/2021

#### Finding

591-1-1-.26(9) requires the playground to be kept clean, free from litter and free of hazards, such as but not limited to rocks, exposed tree roots and exposed sharp edges of concrete. It was determined based on observation that there was a drop off of at least 4 inches on the edge of the cement located at the left area of Playground C, and on Playground D. In addition, the black weed barrier was exposed on Playground E, presenting a tripping hazard. On Playground C, the cement footing was exposed on one fence post on the located between Playground C and D.

## POI (Plan of Improvement)

The Center will fix or remove hazards from the playground and will routinely monitor the playground hazards.
