An Administrative Review was conducted on March 24, 2021. Staff files, children's files, training, and background checks were all reviewed. An in person Initial Licensing Study was conducted on March 24, 2021. The exit conference was conducted virtually on March 30, 2021 (due to computer issues at 4:00 p.m. with the Director. Compliance with the Executive Order issued on February 15, 2021 was reviewed during the inspection and discussed during the exit conference. A Temporary License was issued, pending all approvals. Facility carries Liability Insurance.

- New records checks will be required to be completed if a staff member experiences a six month break in service from the child care industry
- · New clearance is required at least once every five years
- Any staff member solely responsible for supervising children will be required to have completed a comprehensive background clearance
- · All staff members are required to have completed at least a national fingerprint based clearance check
- Any staff member with only the national fingerprint based clearance, must be under constant and direct supervision of a staff member with a satisfactory comprehensive records check clearance
- Facilities are required to use DECAL KOALA for Criminal Records Checks, including to verify portability of an employee

O.C.G.A. Section 42.1.12(i)(2) requires Bright from the Start: Georgia Department of Early Care and Learning to notify licensed child care programs on accessing and retrieving from the Georgia Bureau of Investigation's (GBI) website a list of the names and addresses of all registered sexual offenders. If you do not have this liability insurance, you are required to post a notice with ½ inch letters in a conspicuous location in the program, notify the parent or guardian of each child in care in writing, obtain their signature to acknowledge receipt and maintain this written acknowledgment on file at the program at all times while the child attends the program and for 12 months after the child's last date of attendance. (O.C.G.A. Section 20-1A-4)

591-1-1-.12 Equipment & Toys(CR)

Finding

591-1-1-.12(4) requires that equipment and furniture is secured if it is of a weight or mass that could cause injury from tipping, falling, or being pulled or pushed over. It was determined based on observation that there were computer screens in classrooms A, B, and I that were not secured and could be easily tipped over.

POI (Plan of Improvement)

The Center will secure the computer screens with double Velcro and ensure that they are secured to the tables.

Finding

591-1-1-.25(17) requires that the Center premises be free of plants and shrubs which are poisonous or hazardous. It was determined based on observation that there was vegetation growing through the back fence of playground A and along the exterior side fence on playground B.

POI (Plan of Improvement)

The harmful item will be removed.

Correction Deadline: 3/24/2021

Finding

591-1-1-.25(3) requires the Center and surrounding premises to be kept clean, free of debris and in good repair. Hygienic measures such as, but not limited to, screened windows and proper waste disposal procedures shall be utilized to minimize the presence of rodents, flies, roaches and other vermin at the Center. It was determined based on observation that there were the following items that need repair:

- Classroom B ceiling tile with water stains by the exit door to playground.
- Classroom E chipped paint around the base boards accessible to children.
- Along back side of building there were 4 broken drain pipes accessible to children.

POI (Plan of Improvement)

The Center will repair the ceiling tile, repaint the base boards, and replace the drain pipes.

591-1-1-.26 Playgrounds(CR)

Not Met

Finding

591-1-1-.26(4) requires that playgrounds be protected from traffic or other hazards by a (4) four foot high fence or other barrier approved by this Department. Fencing material shall not present a hazard to children and shall be maintained so as to prevent children from leaving the playground area by any means other than through an approved access route. Fence gates shall be kept closed except when persons are entering or exiting the area. It was determined that there was rust throughout the whole fence on playgrounds A and B. Further consultant observed bolts protruding more than two (2) threads around the gates on playground A.

POI (Plan of Improvement)

The Center will treat for rust, repaint the fence, and cut the bolts back to two (2) threads.

Correction Deadline: 4/7/2021

Finding

591-1-1-.26(9) requires the playground to be kept clean, free from litter and free of hazards, such as but not limited to rocks, exposed tree roots and exposed sharp edges of concrete. It was determined based on observation that the following hazards existed on playgrounds A and B: broken tree limbs, pine cones, pine needles, exposed tree roots, uneven ground with sidewalk, exposed concrete, active ant bed, and thorn bushes growing along back fence on playground A.

POI (Plan of Improvement)

The Center will remove the pine cones, tree limbs, pine needles, spray the tree roots, level the ground around the sidewalks, treat the ant bed and remove the thorn bushes.
