If you do not have this liability insurance, you are required to post a notice with ½ inch letters in a conspicuous location in the program, notify the parent or guardian of each child in care in writing, obtain their signature to acknowledge receipt and maintain this written acknowledgment on file at the program at all times while the child attends the program and for 12 months after the child's last date of attendance. (O.C.G.A. Section 20-1A-4)

Finding

591-1-1-.20(3) requires the Center to maintain a record of medication dispensed that includes the date, time and amount of medication, any noticeable adverse reaction, and the signature or initials of the person administering the medication. It was determined, based on review of medication documentation, that dispensation instructions were not followed as required:

-Authorization for Polymyxin medication indicated that medication should be given April 30-May 4, 2018 at 11:30 a.m.and 3:30 p.m. and was not documented as dispensed a second time on April 30 or May 2, 2018.

-Authorization for Albuterol medication indicated that medication should be given April 23 - May 4, 2018 every four hours and was not documented as dispensed on May 2 - May 4, 2018.
