- New records checks will be required to be completed if a staff member experiences a six month break in service from the child care industry
- New clearance is required at least once every five years
- Any staff member solely responsible for supervising children will be required to have completed a comprehensive background clearance
- All staff members are required to have completed at least a national fingerprint based clearance check
- Any staff member with only the national fingerprint based clearance, must be under constant and direct supervision of a staff member with a satisfactory comprehensive records check clearance
- Facilities are required to use DECAL KOALA for Criminal Records Checks, including to verify portability of an employee





Important Quality Rated/CAPS Update:

As January 1, 2022, child care providers must be Quality Rated to receive Childcare and Parent Services (CAPS). Newly licensed, or new to CAPS providers may be eligible for the new CAPS/QR Provisional Status, allowing for scholarships while working toward a star rating.

It was determined based on observation that there was a shelf with 3 cubbies in the bathroom of classroom A that was not secured and posed a potential tip hazard. Additionally, in classroom D, there was a shelf with 3 cubbies next to the entry door that was not secure and posed a potential tip hazard.

POI (Plan of Improvement)

The Center will ensure that the identified equipment or furniture and any other such existing or future items are secured adequately and will have a system for checking these for stability.

- -In classroom H, a plug in oil air freshener was observed plugged in under the white board near the entry door accessible to children.

The Center will identify all hazardous items and keep them in a locked area inaccessible to children. The Center will inform all Staff about hazardous items and the safe storage of those items.

Finding

591-1-1-.25(8) requires protective caps on all unused electrical outlets within children's reach and requires that electrical outlets in use be made inaccessible to children. It was determined based on observation that the following electrical cord hazards were observed:

-In classroom B, several cords were hanging from the computer desk and posed a potential hazard. Additionally, a brown extension cord was handing next to the white board that posed a potential hazard. In classroom C, two cords were handing off the side of the desk that posed a potential hazard. Additionally, a brown cord was hanging by the filing cabinet that posed a potential hazard.

-In classroom D, a black cord was hanging from the radio and posed a potential hazard. Additionally, several cords were hanging from the computer and posed a potential hazard. Furthermore, a white and blue cord were on the floor behind the desk and posed a potential trip hazard.

POI (Plan of Improvement)

The Center will train Staff to secure all hanging cords to prevent access to children.
