- New records checks will be required to be completed if a staff member experiences a six month break in service from the child care industry
- New clearance is required at least once every five years
- Any staff member solely responsible for supervising children will be required to have completed a comprehensive background clearance
- · All staff members are required to have completed at least a national fingerprint based clearance check
- Any staff member with only the national fingerprint based clearance, must be under constant and direct supervision of a staff member with a satisfactory comprehensive records check clearance
- · Facilities are required to use DECAL KOALA for Criminal Records Checks, including to verify portability of an employee

O.C.G.A. Section 42.1.12(i)(2) requires Bright from the Start: Georgia Department of Early Care and Learning to notify licensed child care programs on accessing and retrieving from the Georgia Bureau of Investigation's (GBI) website a list of the names and addresses of all registered sexual offenders. Finding Associated with Complaint

591-1-1-.15(2)(c) requires age-appropriate solid foods (including cereal) not be given to infants or children less than one (1) year of age until recommended as developmentally appropriate by the child's primary care physician and indicated in writing by the Parent(s) and requires a child to be fed from individual spoons and individual containers or dishes as soon as the feeding plan indicates that a child is ready for solid foods. A child shall not be fed directly from the original baby food container if the contents are to be fed to the child at more than one (1) meal or to more than one (1) child. It was determined based on staff interviews and statements that on September 23, 2022, center staff failed to provide the proper drinking cup that was developmentally appropriate for a four-year-old child that could not drink from a regular cup, and was not given the appropriate sippy cup to drink from is substantiated. It was reported that the child did not consume any liquids, that day, as a result. Staff statements and interviews revealed that on September 23, 2022, when the four-year-old classroom went to lunch in the cafeteria the staff left a four-year-old child's sippy cup inside of their bag in the classroom. Staff statements revealed that a staff member assisted the four-year-old child with drinking from a regular cup during lunch. Staff statements also revealed that when the four-year-old child received snack inside of the classroom later that day, the staff continued to provide assistance with the four-year-old child using a regular cup and did not use the sippy cup that was developmentally appropriate for the child that was inside of the child's bag. Staff interviews further revealed that the staff did not give the child the sippy cup because they are trying to help the child use a regular cup and that the child did obtain fluids that day.

POI (Plan of Improvement)

The Center will ensure that age-appropriate solid foods are given only as recommended by the child's physician and upon written instruction by the Parent(s). The Center will provide a sufficient number of spoons and dishes/containers and will train staff on proper feeding practices, review the procedures regularly and monitor to ensure procedures are followed.
