- New records checks will be required to be completed if a staff member experiences a six month break in service from the child care industry
- New clearance is required at least once every five years
- Any staff member solely responsible for supervising children will be required to have completed a comprehensive background clearance
- All staff members are required to have completed at least a national fingerprint based clearance check
- Any staff member with only the national fingerprint based clearance, must be under constant and direct supervision of a staff member with a satisfactory comprehensive records check clearance
- Facilities are required to use DECAL KOALA for Criminal Records Checks, including to verify portability of an employee





Important Quality Rated/CAPS Update:

As January 1, 2022, child care providers must be Quality Rated to receive Childcare and Parent Services (CAPS). Newly licensed, or new to CAPS providers may be eligible for the new CAPS/QR Provisional Status, allowing for scholarships while working toward a star rating.

Finding

591-1-1-.25(17) requires that the Center premises be free of plants and shrubs which are poisonous or hazardous. It was determined based on a review of records that the premises was not free of plants and shrubs which could be hazardous as a variety of thorny vines, bushes and plants were observed growing through the fence in between the infant toddler and preschool playgrounds. In addition, plants with sharp branches were observed growing through the front left playground (where the picnic tables are located).

POI (Plan of Improvement)

The harmful item will be removed.

591-1-1-.26 Playgrounds(CR)

Finding

591-1-1-.26(4) requires that playgrounds be protected from traffic or other hazards by a (4) four foot high fence or other barrier approved by this Department. Fencing material shall not present a hazard to children and shall be maintained so as to prevent children from leaving the playground area by any means other than through an approved access route. Fence gates shall be kept closed except when persons are entering or exiting the area. It was determined based on observation that the fence in between the infant/ toddler and preschool playgrounds was not in good repair as it contained sharp wires. In addition, the fence between the infant/ toddler and preschool playgrounds contained a gap at the top as it was loose and not secured to the top fence pole.

POI (Plan of Improvement)

The Center will routinely check the fence to determine if it is in good repair and remains at least 4 feet high, and will repair any hazards. The Center will train Staff to identify and report any fence hazards and to keep the fence gates closed when not in use.

The driver or other designated staff person shall document in writing with a different mark/symbol to account for each child listed on the passenger transportation checklist who was not present on the vehicle for any reason. An explanation shall be documented in writing whenever a child is transported to a field trip site but is not present on the return trip to the Center. It was determined based on a review of records that the center did not immediately document in writing with a check or other mark/ symbol during the following times of school transportation:

- Six children were not marked as loaded or unloaded on April 29, 2022 during after school transportation from Pooles Mill Elementary School
- Four children were not marked as loaded or unloaded on April 29, 2022 during after school transportation from Sawnee Elementary School
- Four children were not marked as loaded or unloaded on April 29, 2022 during after school transportation from Matt Elementary School

The driver/other designated person will immediately document in writing with a check/mark/symbol each time a child gets on and off the vehicle.
