- New records checks will be required to be completed if a staff member experiences a six month break in service from the child care industry
- New clearance is required at least once every five years
- Any staff member solely responsible for supervising children will be required to have completed a comprehensive background clearance
- All staff members are required to have completed at least a national fingerprint based clearance check
- Any staff member with only the national fingerprint based clearance, must be under constant and direct supervision of a staff member with a satisfactory comprehensive records check clearance
- Facilities are required to use DECAL KOALA for Criminal Records Checks, including to verify portability of an employee





### Important Quality Rated/CAPS Update:

As January 1, 2022, child care providers must be Quality Rated to receive Childcare and Parent Services (CAPS). Newly licensed, or new to CAPS providers may be eligible for the new CAPS/QR Provisional Status, allowing for scholarships while working toward a star rating.

It was determined, based on observation, that nine children were observed to be housed in classroom Room B. Classroom Room B had a licensed capacity of six children. It was further determined, based on observation, that ten children were observed to be housed in classroom Room D. Classroom Room D had a licensed capacity of nine children.

The Center will limit the number of children in this space to the licensed capacity.

### **Finding**

591-1-1-26(4) requires that playgrounds be protected from traffic or other hazards by a (4) four foot high fence or other barrier approved by this Department. Fencing material shall not present a hazard to children and shall be maintained so as to prevent children from leaving the playground area by any means other than through an approved access route. Fence gates shall be kept closed except when persons are entering or exiting the area. It was determined based on observation that two gaps were observed on the back left fence on the playground that had openings one was more than 10 inches wide and the other was more than 12 inches wide.

### POI (Plan of Improvement)

The Center will routinely check the fence to determine if it is in good repair and remains at least 4 feet high, and will repair any hazards. The Center will train Staff to identify and report any fence hazards and to keep the fence gates closed when not in use.

As soon as the feeding plan indicates that a child is ready for solid foods, the child shall be fed from individual spoons and individual containers or dishes. A child shall not be fed directly from the original baby food container if the contents are to be fed to the child at more than one (1) meal or to more than one (1) child.

Children older than four (4) years of age may be served these foods provided that the foods are cut in such a way as to minimize choking.

It was determined based on a review of staff files that the Director did not have the two (2) hours of state-approved or state-accepted transportation training as required. It was further determined based on a review of staff files that staff #1 and staff #4, did not have evidence of biannually two (2) hours of state-approved or state-accepted transportation training as required.

The Center will ensure that the Director, Center Staff, and any person responsible for the transportation of children has completed the required transportation training.

591-1-1-.14(2) requires a Staff member who is trained in CPR and first aid to be on the premises and on any field trip whenever any child is present. In addition, Staff who provide direct care to children must satisfactorily obtain certification in first aid and CPR by December 29, 2016 if employed prior to September 30, 2016 and within 90 days of their hire date if employed after September 30, 2016. It was determined based on a review of staff files that staff #2 and staff #3, did not have evidence of having completed first aid and CPR.

### **POI (Plan of Improvement)**

The Center will develop a schedule to ensure there is always a staff person with current first aid and CPR training present and will develop and implement a plan to ensure all staff members have satisfactorily completed first aid and CPR training by the specified date.

### **Finding**

591-1-1-.31(2)(b)2. requires teachers and lead caregivers to meet minimum academic requirements and qualifying experience at the time of employment. It was determined based on a review of staff files that staff #2, staff #3, and staff #4 were lead teachers and did not meet the minimum academic requirements.

### POI (Plan of Improvement)

A teacher/lead caregiver will be hired that meets the minimum academic requirements and qualifying work experience.

591-1-1-.32(2) requires the Center maintain Staff:child ratios in mixed-age groups based on the age of the youngest group of children that includes more than twenty percent of the total number of children in the mixed-age group. It was determined based on observation that a ratio of 1:9 was observed in a mixed age-group. When a ratio of 1:6 would be required based off the youngest age- group being under one-year-old children.

The Center will provide adequate staff when there is a mixed-age group.
