The purpose of this visit is to conduct a Licensing Study. This visit was conducted virtually between the Consultant and the Director on February 9, 2022.

An Administrative Review for a Licensing Study was completed on February 17, 2022. Documentation for children's enrollment, teacher's credentials, director's credentials, CPR and first aid and transportation was reviewed by the consultant on this date.

Consultant conducted an exit conference was conducted with the Director on February 17, 2022.

Consultant emailed Licensing Study report to Director on February 17, 2022, requesting signature and emailed back to consultant within two business days.

Plan of Improvement: No Plan Developed

- New records checks will be required to be completed if a staff member experiences a six month break in service from the child care industry
- New clearance is required at least once every five years
- Any staff member solely responsible for supervising children will be required to have completed a comprehensive background clearance
- All staff members are required to have completed at least a national fingerprint based clearance check
- Any staff member with only the national fingerprint based clearance, must be under constant and direct supervision of a staff member with a satisfactory comprehensive records check clearance
- Facilities are required to use DECAL KOALA for Criminal Records Checks, including to verify portability of an employee



Important New Deadlines:

Due to the ongoing COVID restrictions, the deadline to become Quality Rated for programs who want to continue to receive Childcare and Parent Services (CAPS), has been extended to at least December 31, 2021.
