General: Based on review of documentation and interview, a staff, hired on 01/13/20, did not have education verification on file.

922 KAR 2:120. Section 10. Toilet, Diapering, and Toiletry Requirements.

(3) A sink shall be:

- (a) Located in or immediately adjacent to toilet rooms;**
- (b) Equipped with hot and cold running water that allows for hand washing;**
- (c) Equipped with hot water at a minimum temperature of ninety (90) degrees Fahrenheit and a maximum of 120 degrees Fahrenheit;**
- (d) Equipped with liquid soap;**
- (e) Equipped with hand-drying blower or single use disposable hand drying material;**
- (f) Equipped with an easily cleanable waste receptacle; and**
- (g) Immediately adjacent to a changing area used for infants and toddlers.**

Findings:

General: Based on observation, and interview, the hot water temperature registered eighty-two (82) degrees Fahrenheit at the sink in the Infants classroom. The hot water temperature registered eighty (80) degrees Fahrenheit at the sink in the one-year-olds' and two-year-olds' classrooms.

General: Based on observation and interview, the diaper changing mat was torn in several areas in the infants' room. In addition, the diaper changing mat was torn in the one-year-olds' room.

- (b) Meet the physical, developmental needs, and interests of children of different age groups;**
- (c) Be free from sharp points or corners, splinters, protruding nails or bolts, loose or rusty parts, hazardous small parts, lead-based paint, poisonous material, and flaking or chalking paint; and**
- (d) Be designed to guard against entrapment or situations that may cause strangulation.**

Findings:

General: Based on observation and interview, an excessive amount of ice was in the top freezer compartment of the refrigerator/freezer unit in the kitchen.

(3) A serving of milk shall consist of:

- (a) Breast milk or iron-fortified formula for a child:**
 - 1. Age birth to twelve (12) months; or**
 - 2. Beyond twelve (12) months of age as documented by the parent or the child's physician;**
- (b) Pasteurized whole milk for children ages twelve (12) months to twenty-four (24) months; or**
- (c) Pasteurized low fat one (1) percent or fat-free skim milk for children ages twenty-four (24) months to school-age.**

Findings:

General: Based on observation, review of documentation, and interview, a child was not offered a serving of milk with the lunch meal in the preschool room. There was no dietary restriction documented on file.

922 KAR 2:120. Section 8. Kitchen Requirements.

(5) Frozen food shall be:

(a) Kept at a temperature of zero degrees Fahrenheit or below; and

(b) Thawed:

1. At refrigerator temperatures;

2. Under cool, potable running water;

3. As part of the cooking process; or

4. By another method in accordance with the Department of Public Health's food safety standards and permits, established in KRS Chapter 217.

Findings:

General: Based on observation, the temperature measuring device was covered by ice, which made it unable to be determined if the temperature was being maintained at zero degrees Fahrenheit or below, in the freezer in the kitchen.

(1) A child-care center shall maintain:

(b) A written record for each child:

1. Completed and signed by the child's parent;

2. Retained on file on the first day the child attends the child-care center; and

3. To contain:

a. Identifying information about the child, which includes, at a minimum, the child's name, address, and date of birth;

b. Contact information to enable a person in charge to contact the child's:

(i) Parent at the parent's home or place of employment;

(ii) Family physician; and

(iii) Preferred hospital;

c. The name of each person who is designated in writing to pick-up the child;

d. The child's general health status and medical history including, if applicable:

(i) Allergies;

(ii) Restriction on the child's participation in activities with specific instructions from the child's parent or health professional; and

(iii) Permission from the parent for third-party professional services in the child-care center;

e. The name and phone number of each person to be contacted in an emergency involving or impacting the child;

f. Authorization by the parent for the child-care center to seek emergency medical care for the child in the parent's absence;

Findings:

General: Based on review of documentation and interview, two (2) children, enrolled on 11/05/18 and 07/06/14, did not information on file to enable staff to contact each child's physician.

General: Based on review of documentation and interview, the center's evacuation plan was last reviewed and updated on 05/01/2018, therefore, was not in accordance with KRS 199.895.
