General: Based on observation and interview, a white substance was observed on the shelf in the kitchen refrigerator. A red substance was observed in the door in the kitchen freezer. Two (2) ceiling lights were not working in the school age room. The ABC rug had brown spots and frayed along the edges in the preschool room. Also, the tile was stained and dirty in the preschool room.
