Findings: General: Based on Review of Documentation, a 4-year-old child was left alone in a classroom for twenty-five (25) minutes on 8/4/17. The video footage provided by the facility shows two (2) staff and twenty (20) children leave the room to go to the playground while the 4-year-old remained seated in time-out in the classroom. In an interview with one of the staff present it was stated that she did not know that the child was not with the group until she entered the classroom at 3:25 pm and found him still sitting in time-out.

General: Based on Interview, it was found that one (1) staff person was left alone with twenty-one (21) children ranging in age from three to four (3 - 4) years for an undetermined amount of time on 8/4/17. The staff person stated that she left the classroom and went outside to check the condition of the playground. The classroom is located on the second floor. The staff person walked down the hallway to the stairs, went down the stairs and outside to the playground which is located on the ground floor.
