Findings:

General: Based on Review of Documentation, three (3) children, enrolled 03/01/18, 09/10/18, and 09/27/16, did not have the physician's phone number on file. In addition, three (3) children, enrolled 04/06/16, 03/08/18, and 06/01/15, did not have a preferred hospital listed on the enrollment form.

General: Based on Review of Documentation and interview, eighteen (18) children were present on 11/29/18 and only ten (10) children had their arrival time documented. In addition, five (5) parents failed to sign the 94E attendance record for the week beginning 10/15/18, and eight (8) parents failed to sign the 94E attendance record for the week beginning 09/17/18. Surveyor witnessed two (2) parents pick up their children at approximately 1:30 p.m. but a departure time was not documented.
