General: Based on review of documentation, a caregiver hired 11/17/13, had no proof background checks were submitted timely and was employed over ninety (90) days. Also, a volunteer who voluteered at the center since 01/23/14, had no proof a child abuse/neglect check was submitted.

#### 305 - Background checks/discharged

#### **Findings**

General: Based on review of documentation, a caregiver hired 07/16/13, a caregiver hired 06/14/13, and a caregiver hired 05/28/13, completed 3.5 hours training within their first year of employment. - f. Authorization by the parent for the child-care center to seek emergency medical care for the child in the parent's absence;

General: Based on review of documentation, a child enrolled 05/19/14, and a child enrolled 05/15/14, did not have their preferred hospital information documented. A child enrolled 01/17/14, did not have his preferred family physician and hospital information documented. A child enrolled 05/15/14, did not have his family physician's telephone number documented.
