  - 1. A statement from a health professional that the individual is free of active tuberculosis; or

#### Findings:

General: Based on Review of Documentation, a staff person hired 4/19/17 had documentation of being free of TB dated 4/21/17, not prior to employment.

## Findings

General: Based on Observation, in room one (1) the white floor tiles were scuffed and cracked; one (1) tile was broken and missing a small piece. Also, in the room one (1) bathroom the ceiling vent was very dusty. In pre-k academy the caulking between the sink and the wall had a buildup of grime in the creavices and there were yellowish and brownish spot on the wall around the sink. In the pre-k academy bathroom there were three (3) small holes in the wall near the toilet paper holder. In the preschool room bathroom the wall was damaged, the damaged appeared to be caused by a chair scraping the wall.

- e. The name and phone number of each person to be contacted in an emergency situation involving or impacting the child;
- f. Authorization by the parent for the child-care center to seek emergency medical care for the child in the parent's absence;

## Findings:

General: Based on Review of Documentation, a child enrolled on 5/1/17 did not have signed authorization from the parent giving the center permission to seek emergency medical care. Also, three (3) children did not have a preferred hospital listed in their files. The enrollment dates were 8/25/16, 7/25/16, and 4/23/14.
