Findings:

General: Based on Observation, dead bugs were inside the light shield in the toddler 3's room and in the pre-K 2's boys' restroom. Water was on the floor of the toilet room and seeped through cracks of floor tile in front of the toilet room's door in the preschool 1's room. An interview with staff revealed there was a plumbing problem in the preschool 2's toilet room that was not in use. A portion of wall was removed and exposed PVC pipes and the toilet was removed and placed on top of a plastic bag in the preschool 2's toilet room.

585 - Sink Not In Compliance

922 KAR 2:120. Section 10. Toilet, Diapering, and Toiletry Requirements.

- (3) A sink shall be:
- (a) Located in or immediately adjacent to toilet rooms;
- (b) Equipped with hot and cold running water that allows for hand washing;
- (c) Equipped with hot water at a minimum temperature of ninety (90) degrees Fahrenheit and a maximum of 120 degrees Fahrenheit;
- (d) Equipped with liquid soap;
- (e) Equipped with hand-drying blower or single use disposable hand drying material;
- (f) Equipped with an easily cleanable waste receptacle; and
- (g) Immediately adjacent to a changing area used for infants and toddlers.

Findings:

General: Based on Observation, the hot water temperature measured seventy-two (72) degrees Fahrenheit at a sink in the infants' room, toddler 1's room, and two-year-olds' room. Also, the hot water temperature measured seventy-two (72) degrees Fahrenheit at three (3) sinks in the toddler 2's room.

Findings

General: Based on Observation, a three (3) ounce tube of Desitin diaper rash cream, two (2), four (4) ounce tubes of Desitin diaper rash cream, two (2), four (4) ounce tubes of Equate diaper rash cream, two (2), four (4) ounce tubes of Boudreaux diaper cream, a four (4) ounce tube of A and D diaper rash cream, an ounce tube of A and D first aid ointment and skin protectant, and a four (4) ounce tube of Balmex diaper rash cream were each stored unlocked in a plastic white tub on a shelf above the hand washing sink in the toddler 2's room. Also, a sixteen (16) ounce jar of Desitin diaper rash cream was stored unlocked in a child's cubby in the preschool 2's room.

General: Based on Observation, fabric was torn and the inner cushion was exposed on the seat of a stationary activity saucer in the infants' room. A three (3) inch tear was in the seam of a shade hood on a bouncy seat in the infants' room.

General: Based on Observation, an accumulation of dust was on the side of an air conditioning unit in the toddler 1's room. A white charger cord, not in use, drooped down onto a shelf in the early preschool 2's room.
