**(5) The building shall be constructed to ensure the:**

- (a) Building is:**
  - 1. Dry;**
  - 2. Ventilated; and**
  - 3. Well lit, including clean light fixtures that are:**
    - a. In good repair in all areas; and**
    - b. Shielded or have shatter-proof bulbs installed; and**
- (b) Following are protected:**
  - 1. Windows;**
  - 2. Doors;**
  - 3. Stoves;**
  - 4. Heaters;**
  - 5. Furnaces;**
  - 6. Pipes; and**
  - 7. Stairs.**

**Findings:**

General: Based on observation and interview, dead bugs were in a light fixture in the boys restroom and in a light fixture in the girls restroom between Pre-K 1 and Pre-K classrooms. A brown stain was on four (4) floor tiles in the boys' restroom between the Pre-K 1 and Pre-K classrooms.

General: Based on observation and interview, a brown ring was in the toilet bowl in the Toddler II restroom. In addition, a light colored substance was on the toilet seat in the boys' restroom between the Pre-K 1 and Pre-K classrooms.
