Findings: General: Based on Observation, during a tour of the facility on 6/29/17 there were twelve (12) one-year-old children with one (1) staff person in the 1's room. The additional staff person was walking into the classroom through a door that leads from the indoor gross motor room into the classroom as the surveyor and another staff person were walking into the room through the main classroom door. The staff person was carrying a plate of food. An interview with the staff person found she had left the room and went downstairs where the kitchen is located and filled her plate and then came back upstairs and cut through the gross motor room into the classroom. Let it be noted that there is a half wall that is chest level dividing the room. There were six children napping on each side of the half wall. There was one (1) staff person on one (1) side of the half wall. This staff person was tending to various tasks on one (1) side of the half wall.
