General: Based on observation during a tour of the center, the surveyor observed a staff person was not properly wearing a facemask. Staff person was wearing the facemask under their nose. Therefore, the proper Personal Protective Equipment was not being properly utilized. Staff reported that she did not have a doctor's statement exempting her from wearing a facemask.

Based on review of documentation presented, the surveyor found:

- 1. No verification that staff member (DOE: 07/29/20) had a completed Criminal Records Check (CRC). Interview with staff found that the CRC was not available for review. Surveyor witnessed staff member working alone in the classroom.
- 2. No verification that staff member (DOE: 04/12/21) had a completed Criminal Records Check (CRC). Interview with staff found that the CRC was not available for review. Surveyor did not witness staff being alone with children.
- 3. No verification that staff member (DOE: 04/07/21) had a completed Criminal Records Check (CRC). Interview with staff found that the CRC was not available for review. Surveyor witnessed staff member working alone in the classroom.
- 4. No verification that staff member (DOE: 04/15/21) had a completed Criminal Records Check (CRC). Interview with staff found that the CRC was not available for review. Surveyor did not witness staff being alone with children.

During interview, staff stated that classrooms usually have two (2) staff members in the room; however, several staff were out.

Findings

Based on review of documentation presented, the surveyor found that two (2) staff members (DOH: 07/29/2020 and 04/07/2021) files did not contain proof of completed background checks. During a tour of the center, the surveyor observed the same staff members working alone and providing care to six (6) preschool children and two (2) one-year-old children, respectfully. Through interview with staff, it was confirmed that the staff members were left alone with children prior to receiving the results of the completed background checks.
