Findings

General: Based on observation, the following was found:

- 1) A list containing the children's first and last names, emergency contact names and phone numbers, and home phone numbers was posted on the wall of the Elephant Classroom as well as the wall of the Gross Motor Area.
- 2) The name tags on the tables in the Lion and Elephant Classrooms contained the first and last names of the children.

This information was visible to anyone who entered the room; therefore, the children's information was not kept confidential.

General: Based on review of documentation of staff files, the following was found:

- 1) A staff member's (DOH: 11-19-14) file did not contain an annual performance evaluation.
- 2) A staff member's (DOH: 10-9-14) file did not contain a current annual performance evaluation, i.e., the last performance evaluation was completed in September 2015.

General: Based on review of documentation of staff files, there was no criminal records check (CRC) available for review in one (1) volunteer's (start date: 1-7-15) file. Based on review of the DRCC's documentation, there was a CRC that was completed and reviewed for this volunteer during the previous year's survey.

General: Based on review of documentation of staff files, one (1) file (DOH: 4-29-16) did not contain proof of a high school diploma, GED or qualifying documentation from a comparable educational entity, or Commonwealth Child Care Credential as described in 922 KAR 2:250.

- (14) In accordance with KRS 199.896(15) and (16), a staff person with supervisory authority over a child shall complete the following:

- 2. Maintained in a sanitary manner; and

- 1. Liquid soap;
- 2. Adhesive bandages;
- 3. Sterile gauze;
- 4. Medical tape;
- 5. Scissors;

- 10. Disposable gloves; and
- 11. A cardiopulmonary resuscitation mouthpiece protector.

Findings:

General: Based on observation, the first aid kit did not include scissors or disposable gloves.

670 - Medication **Not In Compliance**

- (6) Medication, including refrigerated medication, shall be:
- (a) Stored in a separate and locked place, out of the reach of a child;
- (b) Kept in the original bottle; and
- (c) Properly labeled.
- (7) Medication shall not be given to a child if the expiration date on the bottle has passed.

Findings:

General: Based on observation, there was one (1) tube of Benadryl anti-itch cream located in the first aid kit. The medication was not in a separate and locked place. Based on interview, the director stated that it belonged to a staff member.

General: Based on review of documentation of staff files, the following was found:

- 1) Two (2) staff (DOH: 10-9-14 & DOH: 10-9-14) did not have a professional development plan for review in their file.
- 2) One (1) staff (DOH: 11-19-14) had a blank professional development plan in their file.
- 3) One (1) staff (DOH: 10-9-14) had a completed professional development plan in their file; however, it was not dated. Therefore, it could not be determined if it was a current plan.

- 3. The animal is certified as vaccinated against rabies; or
- (b) Except in accordance with subsection (3) of this section.

Findings:

General: Based on observation, a small fish tank holding one (1) fish was located next to the entrance/exit of the child care center. Based on review of documentation, there is no written parental consent for the children to be around animals at the child care center.
