General: Based on review of documentation, none of the staff eligible for an annual professional development plan had evidence of a plan on file in the facility.

General: Based on observation, there was an uncovered electrical outlet by the changing table in the Infant classroom.

5. The results of background checks conducted in accordance with 922 KAR 2:280;

Findings:

General: Based on review of documentation, one of the personnel files presented for review did not contain a hire date for the employee.

390 - Educational Requirements

(1) Child-care center staff:
(a) Hired after January 1, 2009, who have supervisory power over a minor and are not enrolled in secondary education, shall have a:
1. High school diploma;
2. GED or qualifying documentation from a comparable educational entity; or
3. Commonwealth Child Care Credential as described in 922 KAR 2:250;

Findings:

General: Based on review of documentation, one employee whose hire date could not be determined, did not have evidence of a high school diploma, GED or Commonwealth Child Care Credential on file in the facility.

395 - TB Verification

(b) Shall provide, prior to employment and every two (2) years thereafter:
1. A statement from a health professional that the individual is free of active tuberculosis; or
2. A copy of negative tuberculin results.

Findings:

General: Based on review of documentation, five of the five personnel files presented for review did not contain documentation of negative TB results that had been obtained within the past two years.

400 - CPR/First Aid Coverage

(3) For a child-care center licensed for infant, toddler, or preschool-age children, at least one (1) person on duty and present with the children shall be currently certified by a cabinet-approved training agency in the following skills:
(a) Infant and child cardiopulmonary resuscitation; and
(b) Infant and child first aid.
(4) For a child-care center licensed for school-age children, at least one (1) person on duty and present with the children shall be currently certified by a cabinet-approved training agency in the following skills:
(a) Adult cardiopulmonary resuscitation; and
(b) First aid.

Findings:

General: Based on review of documentation, there was no one on duty and present in the facility with current CPR or First Aid certification. A review of staff files found that there was no one employed by the facility with current CPR or First Aid certification.

(4) Rest time shall not exceed two (2) hours for a preschool-age child unless the child is attending the child-care center during nontraditional hours.

Findings:

General: Based on review of documentation, the posted classroom schedule in the Toddler classroom indicated that nap time was from 12:30 p.m. to 2:45 p.m. This exceeds the two hour rest time limit.

(5) The building shall be constructed to ensure the:

(a) Building is:

- 1. Dry;**
- 2. Ventilated; and**
- 3. Well lit, including clean light fixtures that are:**
 - a. In good repair in all areas; and**
 - b. Shielded or have shatter-proof bulbs installed; and**

(b) Following are protected:

- 1. Windows;**
- 2. Doors;**
- 3. Stoves;**
- 4. Heaters;**
- 5. Furnaces;**
- 6. Pipes; and**
- 7. Stairs.**

Findings:

General: Based on observation, there was an unblocked staircase leading to the second floor in the Toddler classroom. Staff put a gate in place after the children had been in the classroom for approximately 25 minutes.

650 - Toilet

(4) Each toilet shall:

- (a) Be kept in clean condition;**
- (b) Be kept in good repair;**
- (c) Be in a lighted room; and**

Findings:

General: Based on observation, the toilet bowls in both bathrooms used by the children were yellowed and stained.

 - 4. Nonabsorbent;**
 - 5. Easily cleaned; and**
 - 6. Free of any items not used for diaper changing.**

Findings:

General: Based on observation, the changing mat in the Infant classroom was torn leaving exposed foam. The foam cannot be properly sanitized between uses.

 - (a) A current immunization certificate for each child in care within thirty (30) days of the child's enrollment, unless an attending physician or the child's parent objects to the immunization of the child pursuant to KRS 214.036;**

Findings:

General: Based on observation and review of documentation, five of the ten children's files presented for review did not contain a current immunization certificate.

1140 - Enrollment Information

922 KAR 2:090. Section 9. Records.

- (1) A child-care center shall maintain:**
 - (b) A written record for each child:**
 - 1. Completed and signed by the child's parent;**
 - 2. Retained on file on the first day the child attends the child-care center; and**
 - 3. To contain:**
 - a. Identifying information about the child, which includes, at a minimum, the child's name, address, and date of birth;**
 - b. Contact information to enable a person in charge to contact the child's:**
 - (i) Parent at the parent's home or place of employment;**
 - (ii) Family physician; and**
 - (iii) Preferred hospital;**
 - c. The name of each person who is designated in writing to pick-up the child;**
 - d. The child's general health status and medical history including, if applicable:**
 - (i) Allergies;**
 - (ii) Restriction on the child's participation in activities with specific instructions from the child's parent or health professional; and**
 - (iii) Permission from the parent for third-party professional services in the child-care center;**
 - e. The name and phone number of each person to be contacted in an emergency involving or impacting the child;**
 - f. Authorization by the parent for the child-care center to seek emergency medical care for the child in the parent's absence;**

Findings:

General: Based on observation and review of documentation, the following was found:

- 1. One child's file presented for review did not contain any enrollment information, only an immunization certificate.
- 2. Seven out of the ten children's files presented for review did not have documentation of a preferred hospital listed by the parent.

General: Based on review of documentation, there were no policies and procedures presented at the time of the survey that included job descriptions.

(1) A child-care center shall maintain:
(c) Daily attendance records documenting the arrival and departure time of each child, including records that are required in accordance with 922 KAR 2:160, Section 13, if a child receives services from the child-care center through the Child Care Assistance Program;

Findings:

General: Based on interview and review of documentation, there were 12 children signed in on the attendance form; however, there were only 10 children present in the facility. In an interview with the staff present, it was found that two children leave each day to go to another program. There was no record of the children leaving the facility

1175 - Earthquake/Tornado/Fire Drills

(1) A child-care center shall maintain:
(h) A written record of quarterly practiced earthquake drills and tornado drills detailing the date, time, and children who participated in accordance with 922 KAR 2:120, Section 3;
(i) A written record of practiced fire drills conducted monthly detailing the date, time, and children who participated in accordance with 922 KAR 2:120, Section 3;

Findings:

General: Based on review of documentation, the only recorded drill on file in the facility was for a fire drill conducted in January, 2019.

1190 - Orientation Procedure

(3)(b) The program shall include:
2. Written policy that specifies that the procedures that were taught at the orientation training shall be implemented by each child-care center staff member.

Findings:

General: Based on review of documentation, there was no evidence of an orientation procedure for staff on file in the facility.

General: Based on observation, the schedule of daily activities posted in the Toddler classroom was not dated.

1220 - Diapering/Handwashing

(9) The proper methods of diapering and hand-washing shall be posted at each diaper changing area.

Findings:

General: Based on observation, the proper methods of diapering and hand washing were not posted in the changing area outside the bathrooms in the hallway.
