Findings:

General: Based on Observation, at the time of the survey during a tour of the one (1) year old room there were seven (7) children ages one (1) to two (2) years old on one (1) side of the half wall with one (1) staff person. On the other side of the half wall where there are high chairs and a small refrigerator there was an additional staff person getting the children's lunches ready. This staff person was then observed opening the closed gate located in the middle of the half wall and come over to the side with the other staff person and the seven (7) children. Let it be noted that upon entry into the area where the children were the surveyor asked the staff person in the area the age of the children and it was indicated that all of the children were one (1) year old. However, a review of children's files found that one (1) of the children was two (2) years old.

 - 4. Copy of negative tuberculin results or a health professional's statement documenting that the adult is free of tuberculosis. Every two (2) years, the adult shall provide negative tuberculin results or health professional's statement documenting that the adult is free of tuberculosis.

 - (c) An individual who is confirmed by an address check of the Sex Offender Registry and supporting documentation as a registered sex offender;
 - (d) An individual who has been convicted of, or entered an Alford plea or plea of guilty to, a drug-related felony, and five (5) years has not elapsed since the person was fully discharged from imprisonment, probation, or parole;
 - (e) A director who has been convicted of, or entered an Alford plea or a plea of guilty to, a felony offense involving fraud, embezzlement, theft, or forgery; and
 - (f) An individual who has been convicted of, or has entered an Alford plea or a plea of guilty to, an offense under a criminal statute of the United States or of another state similar to an offense specified in this subsection.
- (7) An individual who has been convicted of, or entered an Alford plea or a plea of guilty to, a nonviolent felony or misdemeanor not specified in this section shall be handled on a case-by-case basis by the licensee with consideration given to the:
 - (a) Nature of the offense;
 - (b) Length of time that has elapsed since the event; and
 - (c) Individual's life experiences after conviction, Alford plea, or guilty plea.

Findings:

General: Based on Review of Documentation, there was one (1) staff person with a hire date of 10/30/15 who did not have a copy of a high school diploma, GED or other qualifying documentation on file. During an interview with the staff person in charge it was indicated that this staff person is enrolled in college.

320 - TB Verification

- (b) Shall provide, prior to employment and every two (2) years thereafter:
1. A statement from a health professional that the individual is free of active tuberculosis; or

Findings:

General: Based on Review of Documentation, there was one (1) staff person with a hire date of 10/30/15 who did not have the results of a T.B. test or a statement from a health professional indicating they are free from the symptoms of T.B. on file at the facility. In addition there were three (3) staff with a hire date of 10/15/15. These staff had the results of a T.B. test read on the following dates; 12/11/15, 11/19/15 and 12/8/15. There was one (1) staff person with a hire date of 9/30/15 who had the results of a T.B. test read on 10/13/15 and another staff person with a hire date of 4/27/15 who had the results of a T.B. test read on 5/6/15. All of these T.B. tests were completed after the staff person's date of hire.

325 - CPR/First Aid Coverage

Further review of staff files and the ECE- TRIS system found one (1) staff person with a hire date of 9/1/08 only had evidence of having completed twelve (12) hours of cabinet-approved early care and education training for the 2014-2015 training year. A review of staff files and the ECE-TRIS system also found a staff person with a hire date of 8/10/11 who only had evidence of having completed fourteen (14) hours of cabinet-approved early care and education training for the 2014-2015 training year.

During interviews with staff there was no comment or statement given as to why the medication was administered in this manner.

Another date had not been put in place of what had been erased. In the four (4) year old room Week 22 was listed at the top of the planned program of activities and no date and in the two (2) year old room Week 25 was listed at the top with no date. The school age children were present at the time of the visit because school had been closed due to the weather. However, there was not a daily schedule posted for the school age children nor was there a planned program of activities posted with a date when activities are to be conducted.
