Findings:

General: Based on Observation, at the time of the survey during a tour of the one (1) year old room there were seven (7) children ages one (1) to two (2) years old on one (1) side of the half wall with one (1) staff person. On the other side of the half wall where there are high chairs and a small refrigerator there was an additional staff person getting the children's lunches ready. This staff person was then observed opening the closed gate located in the middle of the half wall and come over to the side with the other staff person and the seven (7) children. Let it be noted that upon entry into the area where the children were the surveyor asked the staff person in the area the age of the children and it was indicated that all of the children were one (1) year old. However, a review of children's files found that one (1) of the children was two (2) years old.



In the four (4) year old room Week 22 was listed at the top of the planned program of activities and no date and in the two (2) year old room Week 25 was listed at the top with no date. The school age children were present at the time of the visit becasue school had been closed due to the weather. However, there was not a daily schedule posted for the school age children nor was there a planned program of activities posted with a date when activities are to be conducted.
