(7) The following shall be inaccessible to a child in care:
(a) Toxic cleaning supplies, poisons, and insecticides;
(b) Matches, cigarettes, lighters, and flammable liquids; and
(c) Personal belongings and medications of staff.

Findings:

General: Based on observation, the following was found:

- 1.) In the diaper changing area outside of the infant classroom, there is a laundry room/storage closet. During the walkthrough, this door was open leaving paint, bleach, and other hazardous items available to the children in care.
- 2.) In bathroom located in the preschool classroom, there were two containers of disinfectant wipes on a shelf within reach of the children. During the exit conference, the staff in charge stated that the children do not use this bathroom. However, the bathroom door was unlocked; therefore, giving those children access to the bathroom and the disinfectant wipes.

580 - Floors, Walls, Ceilings

(9) Floors, walls, and ceilings shall be smooth, in good repair, and constructed to be easily cleaned.

Findings:

General: Based on observation, the following was found:

- 1.) In the two-year-old classroom, there were areas of missing/chipping paint in different locations.
- 2.) In the afterschool classroom, there were areas of missing/chipped paint in different locations.
- 3.) In the restroom located by the kitchen, there were ceiling tiles that were stained. In addition, there were two areas where the black baseboards were coming away from the wall. Also, there were areas of chipped/missing paint underneath the toilet paper holder on the side of the wall with three toilets. There was chipping/missing paint behind the toilets on the other side of the wall where there were two toilets located. There were also areas of mismatched paint, as well as some missing/chipped paint on the wall above one set of the handwashing sinks in that restroom.
- 4.) In the gross motor room, there were numerous foam tiles that were dirty and stained.

This milk was being used for snack when the surveyor entered the facility and was still out after the walkthrough was complete and the children had returned to their classrooms.
