General: Based on observation and interview, a two-year-old child climbed on a table in the two-year-olds' room on 10/26/20. A caregiver grabbed the child's left arm from the opposite side of a table and pulled the child to the end of the table. The center's personnel policy stated, "Charlotte's Web Staff members are expected to be careful and conscientious in performance of duties, including the use of positive words and actions." The caregiver did not follow the center's policy when she grabbed the child's left arm and pulled the child down the side of a table.
