General: Based on observation, the surveyor found that upon entry to the child care center at 11:30 a.m., the staff person in the three year-old children's room was observed to leave the classroom and walk across the hallway and enter the kitchen area. The surveyor went into the classroom and found that ten (10) children were unsupervised and lying on their cots for two to three (2-3) minutes. During an interview with the staff person, she stated that it is "not often" that she leaves the children unattended.

General: Based on observation contained in the files presented for review, the surveyor found the following:

- 1. Two (2) of the children's files did not contain the names and phone numbers of each person to be contacted in the event of an emergency situation involving or impacting the child.
- 2. Nine (9) of the children's files did not contain information to enable a person in charge to identify and contact the preferred hospital.
- 3. One (1) of the children's files did not contain information to enable a person in charge to contact the child's physician.
- 4. The surveyor observed a person, identified by staff as a therapist, alone with a two-year-old child. The staff person in charge stated that she did not know the therapist's name or the agency providing the service. Based on review of the information contained in the child's file, the surveyor found no written parental consent agreeing for the therapist to provide third-party professional services to the child while at the center.

Findings:

General: Based on review of documentation, the surveyor found that the Emergency Preparedness Plan did not contain the following:

- 1. The designated relocation site did not include an evacuation route.
- 2. Instructions relating to the training of staff or reassignment of staff duties.
- 3. Verification that the plan had been coordinated with the local emergency management officials.
- 4. A program to ensure that appropriate staff is familiar with the plan's components.
- 5. The Emergency Preparedness Plan was not dated; therefore, the surveyor was unable to verify that it had been reviewed or revised within the past year.
