Findings:

General: Based on observation on 08/31/11, the surveyor found that a staff person was providing care for five (5) one-year-old children. Another staff person was providing care for six (6) two-year-old children. The classrooms are connected by a door. The teacher in the two-year-old's room asked the teacher in the one-year-old's room to stand in the doorway and supervise the children. She left the classroom to wet wash cloths to clean the children's faces and hands following lunch. During this time, approximately one (1) minute, the teacher provided supervision for eleven (11) children with the youngest child being one-year-old. The staff-to-child ratio was exceeded by five (5) children.
