**Findings:**

Preschool #1: Based on Observation, During a tour of the facility with the staff person in charge at 8:45AM, a child was observed using the bathroom unattended. The staff person in charge identified the child as a four (4) year old from Classroom #1 and indicated that the child was not wearing the "bathroom necklace". The staff person in charge stated that children ask for the bathroom necklace when they need to go to the bathroom; therefore, alerting staff that they need to supervise the child go to the bathroom. The children's bathroom is located down a hallway, approximately twenty-five (25) feet from the doorway of Classroom #1. The person in charge further stated that mirrors are used by the staff to watch the children walk up the hallway to bathroom and return to the classroom. The surveyor proceeded down the hallway to the doorway of Classroom #1 and observed the two (2) staff in classroom to be fully involved in classroom activities with their back to the doorway. The regulations define adequate supervision as meaning that a qualified staff person devotes full-time attention to a child in care and ensures the child is within scope of vision and range of voice. As there was no staff person present with one (1) of the children, adequate supervision was not provided.
