### Findings:

General: Based on observation and interview, the child care center did not maintain the minimum staff-to-child ratio and maximum group size for sixteen (16) minutes during the surveyor's visit, i.e., three (3) toddler children were moved into the preschool room and remained there from 10:44am-11:00am, giving the room a total of fifteen (15) children with two (2) staff members. This took place while the third staff member changed diapers inside the bathroom area, leaving them unable to see the other children. During interview, two (2) staff members stated this is what typically happens during the toddler diaper changing times.

2) Staff with DOH 5-27-13 has not completed the required hours for the training year of 5-27-14 to 5-26-15, i.e., only eight (8) of the required fifteen (15) hours were completed.


