- (a) Six (6) hours of cabinet-approved orientation within the first three (3) months of employment;
- (b) Nine (9) hours of cabinet-approved early care and education training within the first year of employment, including one and one-half (1 ½) hours of pediatric abusive head trauma training; and
- (c) Fifteen (15) hours of cabinet-approved early care and education training during each subsequent year of employment, including one and one-half (1 ½) hours of pediatric abusive head trauma training completed once every five (5) years.

Findings:

General: Based on Review of Documentation, staff hired on 4/8/17, 5/10/17, 7/21/17, 3/24/17, and 5/12/17, had not completed six (6) hours of orientation within the first three (3) months of their employment. Staff hired 8/25/16, completed one and a half (1.50) hours of training; two (2) staff hired 8/25/16, had not completed any training, and a staff hired 8/25/16, completed four and a half (4.50) hours of training. Staff hired 8/25/16 and 12/5/16, completed one and a half (1.50) hours of pediatric abusive head trauma on 10/16/17 and 10/8/17. Staff hired 2/13/17 and 8/25/16, had no proof they completed one and a half (1.1/2) hours of pediatric abusive head trauma training.
