#### Findings:

General: Based on observation, it was found during a tour of the toddler room that there was coffee pot and a jar of coffee grounds accessible to the children in care. These items were on a mini refrigerator in the classroom. There was also a travel mug with coffee in it on top of a shelf in the classroom that was accessible to the children.

#### 580 - Floors, Walls, Ceilings Not In Compliance

#### 922 KAR 2:120. Section 4. Premises Requirements.

(9) Floors, walls, and ceilings shall be smooth, in good repair, and constructed to be easily cleaned.

#### Findings:

General: Based on observation, the following was found:

- 1.) There were two (2) holes in the wall in the bathroom of the toddler classroom. These holes were on the wall to the left of the handwashing sink.
- 2.) In the preschool room, there was an area of the wall next to the tree in the reading area that had peeled and chipping paint.
- 3.) The window sill in the infant two classroom had areas of missing and chipped paint.

#### 640 - Toilet Room Not In Compliance

## 922 KAR 2:120. Section 10. Toilet, Diapering, and Toiletry Requirements.

- (2) A toilet room shall:
- (a) 1. Be provided for each gender; or
- 2. A plan shall be implemented to use the same toilet room at separate times;
- (b) Have a supply of toilet paper; and
- (c) Be cleaned and disinfected daily.

#### Findings:

General: Based on observation, it was found that the toilet paper was being stored on top of a shelf in the bathroom in the toddler classroom. This is not a proper method of storage.

- 1.) There was a white shelf in the library center of the preschool classroom that had contact paper on the top. The contact paper was peeling away from the shelf.
- 2.) There was a green padded mirror in the toddler classroom that was in disrepair.
- 3.) There was a green and blue padded climber toy in the infant two (2) classroom that was ripped and torn.

# 820 - Indoor/Outdoor Equipment
