- (1) A director shall:
- (I) Assure the health, safety, and comfort of each child;

Findings:

General: Based on observation, this regulatory requirement was not met. During a tour of the children's bathroom in the two-year-old classroom, the surveyor found that the roll of paper towels that the children use in the bathroom area is stored in a unsanitary manner; sitting on the sink counter.

The surveyor observed a female child washing her hands in the bathroom during the visit. After the child washed her hands, she reached for the roll of paper towels and knocked it off onto the floor.

The staff person in charge stated during interview that they typically use the paper towel dispenser on the wall; however, indicated that she currently did not have paper towels to fit the dispenser.

General: Based on observation, this regulatory requirement was not met. During a tour of the Preschool Classroom, the surveyor observed a small tear in the dry wall and purple crayon marks on the wall beside a window.



635 - Minimum Toilet/Urinal Requirements

922 KAR 2:120. Section 10. Toilet, Diapering, and Toiletry Requirements.

(1) A child-care center shall have a minimum of one (1) toilet and one (1) lavatory for each twenty (20) children. Urinals may be substituted for up to one-half (1/2) of the number of toilets required for a male toilet room.

Findings:

General: Based on observation and interview, this regulatory requirement was not met. During a tour of the facility, the surveyor noted one toilet in the bathroom in the two-year-old classroom and one toilet in the bathroom in the room currently being used as an infant classroom. The bathroom in the room currently being used as an infant classroom was unusable because it was completely full of various items such as boxes, a child-size chair, and several vinyl climbing mats. This left only one toilet available for the children to use. Since the facility has a licensed capacity of 33 children, the facility is required to have a minimun of 2 toilets for children's use. The surveyor observed 22 children present at the facility during the visit.

The staff person in charge stated during interview that the items being stored in the bathroom would be moved in a few days when the previous infant classroom repairs are finished.
