#### Findings:

General: Based on Review of Documentation, it was found two (2) volunteers who started volunteering at the facility on 5/31/16 did not have evidence of having the application for the results of a child abuse and neglect check submitted. Both of the volunteers are under eighteen (18) years old. However, an interview with the staff person in charge indicated the applications had been submitted but the results had not been received. Neither of the volunteers was observed working alone with the children.

General: Based on Interview, with staff in the infant and toddler area staff indicated that when cleaning toys that have been mouthed they use soapy water and a rag to clean the toys and then use a sanitizer and let them air dry. 
